DECISION

6. Pharmaceutical chemicals in the original packaging

Explanation

"PHOENIX PHARMA" doo Belgrade, no. 2, Bore Stankovica Street, submitted the request on 11 June 2014 for the issuance of the marketing authorisation for the trade of medicines and medical devices, as well as pharmaceutical chemicals in the original packaging in its business premises in Novi Sad, no. 2, Privrednikova Street.

Acting in accordance with the submitted request, pursuant to Article 208, paragraph 3 item 2, an inspector for medicines and medical devices has performed the review of the submitted documentation, as well as the inspection of the warehouse with the surface area of 3391.63 m2 in Novi Sad, no. 2, Privrednikova Street and determined that the prescribed requirements for performing the activity of marketing of medicines and medical devices listed in the wording of the decision, as well as the pharmaceutical chemicals in the original packaging were met, as he/she recorded in the minutes dated 30 June and 16 July 2014, in accordance with Articles 120 – 123, 193, 194 of the Law on Medicines and Medical Devices ("Official Gazette of RS", no. 30/10) and Articles 3, 10, 11, 13, 15, 21, 22 and 30 of the Rule Book on the requirements for the wholesale of medicines and medical devices, data entered into the Registered of the marketing authorizations issued for wholesale trade of medicines and medical devices, as well as the method of registration ("Official Gazette of RS", no. 10/12).

Based on the foregoing, it has been decided as stated in the wording of the decision.

This decision is final in the administrative procedure.

Administrative proceedings before the competent court may be initiated against this decision within 30 (thirty) days from the date of receipt of this decision.

The fee for this decision was charged in accordance with the Law on the State Administrative Fees ("Official Gazette of RS" no. 70/11 and 47/13).
